What Practical Is Required?

AAOES Level 3 accreditation requires the Official to complete twenty (20) days of practical which includes at least five (5) days at State Championships including three(3) as a Chief or Referee prior to sitting the examination. The Official will be assigned a Mentor to assist with the learning process. **Only** a Level 3 Official or the Official's appointed Mentor may sign the card.

The Official must advise their Mentor or a Level 3 Official that they wish to be observed carrying out their assigned duties **prior** to competition.

The Official must demonstrate that they have worked across all areas within the event discipline e.g. for Track – Umpire, Starters Assistant, Track Judge OR Photo Finish, Umpire, Starter.

The 20 days must include:

- No more than 10 days at an interclub competition (in the discipline), including at least five (5) days as a Chief or Referee
- No less than five (5) days at State Championships (including three (3) days as a Chief or Referee).
- No Less than five (5) days at a National Championships.
- SC = State Championship
- NC = National Championship
- O = Other, including Interclub, schools competition

In addition to the practical component, Officials must attend two (2) seminars in the discipline. This should be written on this card before it is submitted.

What Next?

Once you have completed the 20 days practical and 2 seminars in the discipline, Officials should then send their practical card to their Member Association, who will then check that the required practical components and seminar attendance have been fulfilled before the exam may be attempted.

Your member association representative will then provide you with details for the exam.

INSTRUCTIONS TO CANDIDATES

It is the Official's responsibility to arrange practical proficiency assessment at-a competition, by an appropriate Assessor. The Official must inform the Assessor that they wish to be assessed **prior** to the start of the event so that the Assessor can effectively assess the competence of the Official. This is a **mandatory** requirement.

When all requirements are completed, Officials should then send their practical card to their Member Association who will verify the components before the Level 3 exam may be attempted.

EVENT GROUPS:

The elements within each Event Group are:

TRACK: JUMPS: THROWS:	judging, timekeeping, umpiring, starting, photo finish, wind gauge long jump, triple jump, high jump, pole vault shot put, discus throw, javelin throw, hammer throw
COMPETITION	
MANAGEMENT:	recording, seedings/draws, announcing, meet management areas, call room, post event control
TECHNICAL:	equipment measurement, field event site layouts (all areas), equipment distribution
WALKS: OUT OF STADIA:	walk judge: track, and road, posting board, recording starting, umpiring, judging, recording, timekeeping, course setup
